  - a. The Treasurer's report was approved after a brief discussion..

- 6. Report from Willamette Community Management. Kurt
  - a. Assessment delinquencies. There is still one owner in significant arrears. Owner is probably out of the country. Otherwise, delinquency collections are in good shape, with only a few owners slightly behind.
  - b. Went over the major aspects of our income and expenses.
  - c. Maintenance Roofing company wanted to delay work until March of next year. Kurt prevailed on them to agree to doing one roofing per month starting this month. Company has stated that if any damage occurs because of their delay, they will perform the necessary repairs and pay to fix any damage caused by this delay.
  - d. Earthquake insurance Cost is increasing significantly. Kurt will obtain several quotes and Board will decide on how to proceed
  - e. Armor has started the building exterior maintenance and repairs. Materials cost has greatly increased, and we are charged as the work proceeds. Kurt will obtain estimates from Armor for use of cedar versus synthetic materials for use in the remaining work.
  - f. Budget Was discussed at the Annual meeting.

- 1. There was some additional discussion of options regarding handling major delinquencies.
- 2. Date and location of next meeting will be in mid- to late-February, with specifics to be determined at a later date.
